change things.



The Japan earthquake and tsunami brought immediate concern for fellow Gordon clansman, Tei Gordon and his family. Following a quick email to inquire as to his safety we were re-

lieved when Tei replied the day of the earthquake:

"Thanks for checking on us. Pretty crazy in Tokyo.

Actually, I am back in Oregon, but all my neighbors appear to be in my place in Odaiba. The towers behind my building have cracks in the walls from the ground to 42nd floors, but my building is and only 5 stories and unscathed. They say another building in the neighborhood caught fire.

My sister is staying at my place, but says all is well.

Unbelievable."



Odaiba is a man-made island in the middle of Tokyo Bay across the Rainbow Bridge from Tokyo Center City. Pictures of the fire Tei mentions were widely publicized.

On April 9th Tei wrote:

"Thank you for thinking of me.

All is well. I have actually been back between Oregon and Hawaii since one week before the earthquake, Tsunami, and subsequent nuclear event. My sister was staying at my condo, right on the beach in the middle of Tokyo Bay, so it was scary for her, but she fortunately found a flight back to the west coast the day after.

It is tragic what is happening in northeast Japan and I am not yet sure how it will affect my business, but if any society can pull through in the face of adversity, it is the Japanese.”

Tei is currently back in Tokyo organizing a fund raiser for relief of the victims of the earthquake, tsunami and nuclear events.

DNA Project Report

Jim Gordon Co-Administrator

This has been an eventful year for the Project. Tei has teamed up with Bill Howard a post-Doctoral researcher from Harvard University to co-author a paper *The Evolution of the Gordon Surname: New Insight From Y-DNA Correlations and Genealogical Pedigrees* for the International Society of Genetic Genealogy (ISOGG) Journal. The paper introduces a new analytical tool for genealogy using DNA called "clustering." This new technique shows remarkable relationships among pedigrees, cluster and sub cluster membership, geographical location, and their evolution has become apparent through this study. The appearance of surname sub clusters within a surname cluster can indicate a strong, confirmable tie to pedigrees when they are available for members of a sub cluster.

Tei and Bill have uncovered correlations between recent historical activity and the formation of sub clusters. The times when Gordon family clusters first appeared, and when the most recent common ancestors of Gordon inter-clusters lived, are compared with the chronology of the Gordon surname and events in European and Scottish history to provide additional insight into the history of the Gordon surname and possible origins from 2500 BCE to the present. The earliest most recent common Gordon ancestors who were located in pairs of different haplogroups date to about 17,500 BCE, just after the European glaciers in the most recent ice age began to recede.

In the R1b1 haplogroup, the ISOGG time estimates, the Revised Correlation Coefficient (RCC) [A mathematical concept] time scale, the Y-DNA evidence and our

results are consistent with an origin of the Gordon surname in areas near modern Turkey and Greece. Comparison of the ISOGG dates with those determined using the RCC time scale shows good agreement and no inconsistency between the RCC - and ISOGG-derived estimates. The times derived from the RCC matrix for the early migrations of the I1 haplogroup into the British Isles from Scandinavia and from Western Europe agree well with the history of the area derived from archaeological excavations, genetics and anthropologic studies.

Bill Howard has gone on to author several more papers using this paper as a basis and has also collaborated with colleagues on using these new concepts.

EDITOR'S NOTE:

This is an important study and gives our Gordon DNA Project credibility in both scientific and genealogical circles. It is interesting to see that our DNA study does support ancient origins mentioned in historical records and by earlier researchers with connections to Normandy, and even more ancient Gordinia (Turkey) and Gordonia (Macedonia) where previously these were merely assumptions based on a similarity of name alone! The possibilities of sorting the various connections the origin of our clan of surnames as Swinton and Seton and Geurdon/Gourdon through future testing of men of known pedigree of various surname with possible historical ties to the clan are exciting. The more we can include in our project, the more we will understand of our origins.

Dance camp kicked off with the Mid West Highland Dance Association Camp on the beautiful Lake

Itasca near Summerside, Michigan. During the day, we have workshops in log cabins or under cabanas down by the lake. In the evenings, I attended optional technique, turnout, and strength classes. Then it was straight to Ohio for the Ohio Scottish Games, where I competed in the highland, choreography, and championship competitions, and then the Ohio School of Scottish Arts School! This week-long camp is taught by highland dance instructors from all around the world and is held at Oberlin College. Fun doesn't even begin to describe getting to attend day-long dance workshops with friends from across the country on a college campus for a whole week! I definitely wish it was longer. Once OSAS was over, we were off to Minneapolis, North Carolina for the School of Scottish Arts. You couldn't get any reception up there between all those huge mountains, but it was definitely worth it! This camp was also a week long and, as always, we got to attend highland dance workshops for about six hours a day, but my favorite time was after lunch and dinner when you could come in class early and get one-on-one time with the teacher, which was so helpful and exciting! Once dance

camp sadly came to a close, my mother and I headed to the nearby Grandfather Mountain (where we camped!) where I participated in the Atlantic International Highland Dance Championship on Saturday, and the Nationals Competition on Sunday.

My final dance camp of the year was the Ann Milne summer dance camp in Owen Sound, Ontario. Not only was this my first dance camp in Canada, but we were taught by a four-time World Champion for six hours a day! Before the camp, my father took me to the Glengarry (Maxville) Highland Games, where I competed in the Nationals Competition on Friday and the Championship on Saturday, and also the Montreal Highland Games on the Sunday. Right after camp came the United States Inter-Regional Highland Dance Championship. I participated in the Choreography and Nationals Competition on Friday, the actual USIR on Saturday, and the North American Championship on Sunday, and getting to watch and hang out with other dancers from across North America was a blast!

My last big competition of the year was the World Highland Dancing Championships in Cowal, Dunoon, Scotland. I first had to qualify in the preliminarily round on Friday to be able to dance in the actual Championship on Saturday. The experience and the atmosphere at Worlds really is just as awesome and unique as all the things I've heard about it - and the overall quality of dancing there is unlike anything I've ever seen!

Thanks again Clan Gordon for awarding me the scholarship!


Headlines Screamed "WORLD COMING TO END—STRANGE NEW PLANET RUSHING TOWARD EARTH—ONLY MIRACLE CAN SAVE US, SAYS SCIENCE." So the story of Flash Gordon began on January 7, 1934. Alex Raymond's space fantasy with his wonderful art and style captured the imagination of America in the depths of the Great Depression. A Yale man and internationally renowned polo player, Flash Gordon was the ideal blonde, blue-eyed All American man; smart, athletic, brave and resourceful, he made Americans feel good about being American when things were on the

down and out all around them. Flash Gordon was the miracle.

The Flash Gordon comic strip continued with new adventures and continuities for an astonishing run of over 69 years from its debut in 1934 to its last new Sunday strip on March 16, 2003, when it went into reruns. It inspired three movie serials starring Olympian swimming legend Buster Crabbe as Flash, and Charles Middleton as Ming the Merciless; two radio serials starring Gale Gordon as Flash Gordon!; three animated series; three live action series; numerous comic books; a magazine; several novels, a whole futuristic exhibit-ride at the 1939 World's Fair; a 1980 Cult Classic film full of campy fun and a FANTASTIC sound track by QUEEN; and it inspired George Lucas influencing the style, look, feel and story of his Star Wars series.

Flash Gordon introduces the quintessential American story to the space sci-fi genre, that of a noble and heroic rebellion fighting against an evil tyrannical and illegitimate empire — the story of our own revolution against British oppression — a story which was largely influenced

by the Scottish struggle for independence and freedom from English oppression. Gordon was the perfect surname for a hero embodying the traits needed to "Conquer the Universe." After all, the Gordons are known for their overwhelming nature pushing all obstacles out of the way of their objective. With



Adam Gordon who championed the Scottish Freedom movement acting as ambassador for Robert the Bruce to the Pope in presenting the Declaration of Arbroath as an example, what better family to put forth the hero of the earth and universe?

The Flash Gordon Movie Serials starring Buster Crabbe (Flash Gordon: Space Soldiers 1936, Flash Gordon's Trip to Mars 1938, and Flash Gordon Conquers the Universe 1940) were the most expensive serials ever made, and were so popular that they were generally advertised *above* the main feature — a movie history first and last!

George Lucas originally wanted to do a remake of these serials, but could not negotiate the rights with King Features, and made the momentous decision to create his own Gordon inspired story. Star Wars is filled with the style, feel and plot inspired twists of the 1930's Flash Gordon Movie Serials, beginning with the Star Wars signature text-crawl at the start of each episode — taken right out of the Flash Gordon serials. Other influences readily noticed are found in the soft wipes be-



tween scenes, the underwater city with manta ray- shaped submarines, the cloud city, the forest kingdom of Arboria inspired the Wookiee tree houses of Kashyyk and later the look of Endor, while the swampy part of Arboria inspired Dagobah. The cave kingdom of Kira brought us Geonosis; Queen Fria's icy kingdom of Frigia inspired Hoth, and the jungle kingdom of Tropica inspired Yavin IV. Oh! And don't forget that the blonde, blue-eyed looks of hero Luke Skywalker come from Flash himself, while Leia's infamous buns come from Queen Fria's hairstyle from the Sunday comics!



Flash overran the American imagination and fueled speculation on future technology in many instances presaging developments in science, or maybe more truthfully, inspiring many young future scientists (and even 1930's contemporary scientists) to bring to life the scientific wonders of the Flash Gordon cartoon. I have often wondered if future Disney Imagineer and originator of audio-animatronics, Lee Adams, was one of those inspired by the 1939 World's Fair Flash Gordon Ride/Exhibit that was featured in Popular Science. Taking 150

people at a time on a rocket ride complete with vibrating seats immersed in a simulated movie screen trip to Venus where they could then get out and explore. Flash Gordon beat Disney to the World’s Fair with mechanically animated creatures by 25 years!



the name “The Rocket Raiders” and Raymond designed their patch. Just one more influence on my three Marine sons!

But my favorite Flash Gordon influence will always be the campy 1980 film with the Queen soundtrack that convinced me David’s humor meshed well with mine! There were at least 50 in our group that night all yelling out “FLASH AH-AH!” “He’ll Save Every One of US!” *Oh! the memories!*

So much has been influenced by the Flash Gordon comics over the years that there is no way to catalog it all. My eldest son was a huge fan as a child of the Thundercats— Lion-o must surely be a descendant of Prince Thun of the Lion men. I am grateful for Thun’s positive influence.

Flash’s creator, Alex Raymond, was a patriot and so Flash came back to earth in 1941 to fight against evil for the USA. In 1944, Raymond joined the Marine Corps and fought in the Pacific on the USS Gilbert Islands alongside my father’s ship in Admiral Halsey’s task group. Rhode Island's Infamous Gordon Past Revisited!

Governor Chafee asked to posthumously pardon last man executed in Rhode Island

PROVIDENCE — It's a story passed down through generations in Rhode Island, the tale of John Gordon, an Irish immigrant whose execution by hanging spurred the state to do away with the death penalty.

As the tale is widely told, Gordon was wrongfully convicted of murdering a wealthy Yankee mill owner after a trial that was rife with prejudice against Irish Catholics and pitted the upper class against the immigrant class. The evidence was circumstantial, as told, and the judge biased. Gordon was hanged on Valentine's Day in 1845 after his appeal failed before the same judges who heard his trial. Discontent about his death would lead Rhode Island to become one of the first states in the nation to abolish the death penalty seven years later.

And now, a state lawmaker has submitted legislation some view as an opportunity to right a wrong. Rep. Peter F. Martin, D-Newport, has sponsored a measure calling for Governor Chafee to posthumously pardon Gordon for the murder of Cranston industrialist Amasa Sprague.

"I expect him to love to do this pardon," Martin said, noting Chafee's Yankee roots. "We want a statement that says the evidence was such that we think he

was never guilty."

Martin was asked to submit the bill by Ken Dooley, the author of a play now showing in Cranston that details Gordon's trial, he said. After learning more about the case than his father had told him as a child growing up in Newport's Fifth Ward, Martin said he became convinced a pardon was the only way to fix a grave injustice.

"The State of Rhode Island created this problem," he said. "The State of Rhode Island has the responsibility to remedy it."

The measure has the backing of the Roman Catholic Diocese of Providence, long a foe of capital punishment, and Office of the Public Defender.

"I think it rights a wrong," said the Rev. Bernard A. Healy, the diocese governmental liaison who plans to lobby on behalf of the pardon. The diocese, he says, views it as a teachable moment about "innocent people getting killed by the death penalty" and attitudes toward immigrants. The Irish, at the time, were economic refugees seeking a better life in the United States after being hit by the potato famine, not unlike immigrants of today, he said. "The same thing could happen today."

The public defender's office, too, plans to add its voice to the cause. "The entire process was very problematic," said Michael DiLauro, assistant public defender.

DiLauro, who's long held a fascination with Gordon's case, acknowledges he might not be able to prove that Gordon didn't kill Sprague near his Cranston mansion.

“Given the age of the case and the nature of the evidence, the kind of certainty that you would get today in a post-conviction DNA-exoneration case is not possible,” DiLauro said. “But if you look at the record in the case, the proof that found this guy guilty was not only minimal, but was, at best, circumstantial and, at worst, unreliable.”

That perplexes some historians. The Rhode Island Historical Society doesn't have a position on the pardon request, but welcomes an examination of the crime and an exploration of the issues it raises about the state and its values, said Morgan Grefe, the director of education and public program at the Historical Society.

“The question is, as a historian, is there enough evidence to prove innocence, or just that there wasn't a fair trial?” Grefe said.

“We certainly always support looking into the past and bringing to light as best they can what happened in 1845,” she said. “Sometimes that's easier said than done.”

In Cranston, historians are more convinced. “[Gordon] had nothing to do with it,” said Lydia Rapoza, president of the Cranston Historical Society. “He was drunk somewhere.”

The state's chief law-enforcement officer, whose office is responsible for prosecuting most crimes in the state, refrained from taking a stance.

“The attorney general believes the decision should be based on law and the facts, not emotion and historical accounts which over decades can change and shift,” said Amy Kempe, spokeswoman for Attorney General Peter F. Kilmartin.

Mill owner Amasa Sprague was shot and beaten to death on the banks of the Pocasset River on New Year's Eve 1843. Suspicion soon fixed on the Gordon family, Roman Catholic immigrants from Ireland. Sprague had had several clashes with John's brother, Nicholas, about his workers coming to the mill drunk after buying liquor at Nicholas' store. Sprague, the brother of U.S. Sen. William Sprague, convinced city officials to suspend Gordon's liquor license.

Soon after Sprague's murder, authorities arrested John, his two brothers, mother and even Nicholas's dog because tracks indicated a dog had accompanied the suspect. The Providence Journal, criticized for its biased accounts, reported the evidence against the Gordons was so strong “it is now settled opinion that they are the guilty parties.”

The Gordons' trial in 1844 came at a time of anti-immigrant hysteria against Irish Roman Catholics, the first group to immigrate in large numbers threatening the hold of Yankee Protestants. A total of 102 witnesses testified over nine days, giving at times confusing and contradictory testimony. A judge was said to have instructed the jurors to give greater weight to Yankee witnesses than Irish witnesses.

The jury returned shortly, acquitting William and finding John guilty of murder. Another jury came back hung at Nicholas' trial. John's appeal was rejected by the same judges that oversaw his trial.

John Gordon was hanged before 60 prominent Rhode Islanders at a prison yard that is now home to the Providence Place mall. His body was buried in a pauper's grave in the North Burial Ground after a funeral procession that drew thousands. His body was then se-

cretly moved to an unmarked grave at a consecrated cemetery at St. Mary's Church in Pawtucket. Once a year, the Irish Society holds a ceremony there, said Father William J. Ledoux, church pastor.

Under the state Constitution, the governor can grant a pardon with the advice and consent of the Senate. Governors receive 10 to 15 requests for pardons each year, some written on slips of paper, according to Claire Richards, Governor Chafee's chief legal officer. The governor's staff asks the person seeking the pardon to provide detailed information about his or her criminal record, sentence and conduct while serving time. Only one or two people fulfill that request, and the governor's legal counsel then makes a judgment call based on the information they provided, Richards said.

Richards was not aware that a pardon had ever been granted in Rhode Island. She declined to give specifics about people who requested pardons during her tenures with Governors Lincoln Almond and Donald Carcieri.

If the House of Representatives back the legislation, lawmakers would be expected to provide the governor with detailed evidence supporting the pardon request, said Michael Trainor, Chafee's spokesman.

"The governor understands the spirit with which this resolution is being offered. He's sympathetic to that," Trainor said. "He still has to follow the rules. ... He'll look at the evidence and he'll have to make a determination."

Sprague descendants are reluctant to weigh in.

"I defer to the historians," said Robert Cocroft, a copy editor at The Providence

Journal who descends from William Sprague, Amasa's brother, a former U.S. senator and Rhode Island governor. "I don't know what happened. I wasn't there."

UPDATE! 11 MAY 2011

The House voted 65 to 0 to pass the measure sponsored by Rep. Peter Martin, D-Newport, asking Chafee to pardon John Gordon, whose hanging on Valentine's Day in 1845 spurred the state to do away with the death penalty.

The resolution will now work its way through the Senate, beginning with the committee on Special Legislation and Veterans' Affairs.

The resolution has been embraced as a chance to right a grave injustice by disparate interests that include Assistant Public Defender Michael DiLauro, historians, the Rhode Island Affiliate of the American Civil Liberties Union and the Roman Catholic Diocese of Providence. Under the state Constitution, the governor can grant a pardon with the advice and consent of the Senate.

Martin said Wednesday's vote didn't signal that lawmakers believed in Gordon's innocence, but rather that the evidence wasn't enough to prove his guilt. "They certainly today would have done more investigating," Martin said.

The Irish Times is also reporting on this story and has quoted Rep. Peter Martin as saying, "I was brought up understanding two things, that the Irish endured prejudice here, and that a young man hanged for a murder he did not commit." The resolution is expected to pass in the Senate as well, and Rep. Martin expects Governor Chafee to sign Gordon's pardon "within weeks, not months".

Barbara Wray, secretary, read the 2009 AGM Minutes held October 24, 2009 at the Meadow Highland Games in Doswell. David Whiteside made a motion to accept the minutes as read and Geof Baker seconded. All voted aye. A copy of the minutes will be posted on the National website and will also be filed for audit.

Reports:

President's Report - Kim Gordon read his report on the progress made since last October regarding goals set out at the AGM in 2009. He indicated that he'd like to see us triple our membership within 18 months. Kim touched on points such as New membership systems, Conveners and Regional Commis-

sioner Expansion, adding a newly appointed Quartermaster, John Gordon of southern Illinois, new financial and budgeting systems, increased communications with our International partners, newsletters and mailings and Facebook and Website applications. David Whiteside made a motion to accept the President's report as read. David Todd seconded it. All voted "aye".

Treasurer's Report – Nellie Lowry who could not attend this year's meeting provided her treasurer's report. Total income for the period from July 1, 2009 through June 30, 2010 was \$7,268.82. Total expenses were \$10,903.00. An increase due to the cost of printing and mailing the May annual for \$4,085.85 (600 copies); the allocation of Charles O. Gordon Scholarship Fund for \$2000.00; and increasing the donation to the Gordon Highlanders Museum to \$2000.00. Our remaining operating balance is \$15,158.78. A copy of Nellie's report was provided at the meeting for review. Lois Todd made a motion to accept the financial report as read and Ginny Gordon seconded it. All voted "aye".

Membership Report – Arlene Adams indicated in her report that many organizations find it hard to retain members, yet the renewing members are most important for us to encourage to continue with their support. New membership will help expand the House. Currently we have 765 new, active and inactive members. Lu Gordon made a motion to accept the membership report as read and David Todd seconded it. All voted "aye".

Vice President/Convener's Chair Report – Geof Baker welcomed everyone for coming to the meeting. He welcomed new conveners, Michael Hilden and Julie Bowman, co-conveners for Minnesota and John Gordon, convener for southern Illinois & Missouri. John as also graciously accepted the newly created position of House of Gordon Store Quartermaster. This is a new position and

we now have 9 Board members.

He discussed monies from the Heritage fund creating standardized "Conveners Kits" to help new conveners and developing a "Brand Standard" for clan tents for festivals and games, i.e. making all our tents readily recognizable at a distance as GORDON. He also discussed conveners collecting dues for their states but not reporting to National. This goes against our 501(c)(3) non profit status and could potentially lead to loss of our status if not complied to.

We have made a commitment to increase our membership by 25% this year. Barbara, Lois and Morris attended the Greenville, SC games and have already received a few new memberships generated from those games.

Communications Report – Lois Todd read her communications report to everyone. Highlights were amount of hits to our website are down this year by 3.32%. We are seeing a rise in hits from our fellow Gordon's in Russia. Valeria Morris has started the House of Gordon in Russia. Our Facebook House of Gordon USA Group now has 319 members and is growing. We currently have 76 videos in our House of Gordon Playlist on YouTube. One of the biggest challenges we have is contacting our members. Email addresses and home addresses change and we don't get the updates. Another challenge is the cost of communication. Most is done electronically, however the cost for the annual newsletter is approximately \$6.30 each and that is 63% of the national portion of the dues of \$10.00. We are looking at ways to streamline these expenses. Barbara Wray made a motion to accept the communications report as read and Ern Malcolm sec-

onded it. All voted "aye".

Scholarship Report – Lois Todd read her report. This year we voted to sponsor 3 scholarships of \$500.00 each. This year's winners were Miss Jean Stein of Elgin, Illinois, Miss Zoe Shell of Elizabethton, Tennessee and Mr. Marshall C. German of Corona, California. David Whiteside made a motion to accept the scholarship report as read and Brandie Bartos seconded it.

DNA Project – Lois Todd read this report. This report is presented by Lois Todd, Jim Gordon and Tei Gordon. Tei Gordon is now working on a new project with an astrophysicist. To date we have helped 4 applicants. The House of Gordon USA has donated \$1000.00 to help finance the cost of testing. Morris Gordon made a motion to accept the report as read and Bonnie Linse seconded it. All voted "aye".

Items of Business:

Article 4, section 2 of the Bylaws proposed change to restrict the board and officers to non family affiliated members: Discussion revolved around the bylaws provision for voting members of no more than 11 but no less than 4 officers on the executive board, and the possibility of a conflict of interest occurring when members of the Board of Directors being directly related or marital partners (i.e. Father and son, man and wife). Jim Drouillard, a member in Texas, headed up a care package day in his community and wore his Gordon kilt and used the opportunity to tell people about our military history and 4 pages of Medal of Honor recipients!

It was proposed that we change this to holding the money in our treasury and when Jim, Tei and Lois have a need for a kit to be funded then we write the check to Family Tree DNA. 
